Program Profile

M.A. program "Political Economy of the ASEAN-Russia Strategic Partnership" aims to train a group of ASEAN and Russian students willing to engage with each other beyond classrooms and to make ASEAN-Russia strategic development part of their career paths. There is no similar educational program in any other Russian or ASEAN University. Yet, experts in Russian foreign policy, as well as experts in Southeast Asian affairs are in high demand both in Russia and ASEAN member states. The program provides students with the necessary skills for employment in the governmental agencies, international organizations, business analytics and consulting. The curriculum best serves those students who would like to be directly involved in promoting ASEAN-Russia cooperation, to create and implement business or socio-cultural projects together. Courses are designed to help graduates embrace their role as global citizens, entrepreneurs and diplomats who would like to align with an international and multicultural environment. Program's interdisciplinary approach entails a constellation of several thematic courses blocks of such as regional and global processes, macroeconomics and contemporary international economy, ASEAN-Russia relations as well as different aspects of international relations, regional integration, business cultures and digital economy with a focus on Russia and ASEAN.

Basic Course Structure

The curriculum of the program "Political Economy the ASEAN-Russia Strategic Partnership" consists of core disciplines and elective courses. That allows each student to opt for an individual schedule appropriate to their professional interests and personal inclinations.

The work is divided among lectures, seminars and workshops formats based on field research, visiting experts' participation, and group reports. For successful graduation, students are obliged to pass final exams and defend the Master's thesis.

During your studies you will:

- Learn to analyze Russia and ASEAN's role in the world economy, global and regional politics;
- Explore regional integration processes involving Russia and ASEAN as well as their political and economic development;
- Gain an understanding of the international political, trade and investment, legal, digital, and technological dimensions of ASEAN-Russia relations;
- Learn how to apply this knowledge and analytical skills to the real life situations during internships in the leading Russia and ASEAN think tanks, companies, state agencies and NGOs;
- Be able to professionally organize political, economic, business, media and intercultural communication between ASEAN and Russia.
