

**STUDENT EXCHANGE MEMORANDUM OF UNDERSTANDING
BETWEEN
CHIANG MAI UNIVERSITY
AND
THE UNIVERSITY OF THE RYUKYUS**

Chiang Mai University and the University of the Ryukyus shall exchange undergraduate and graduate students under this memorandum based on the Basic Agreement on International Exchange Between Chiang Mai University and the University of the Ryukyus signed on December 18, 1989.

1. Number of Exchange Students

Each university may send and accept under this memorandum not more than five students each academic year.

2. Duration of Stay

Duration of stay of exchange students at the host university shall be in principle for up to one academic year.

3. Selection of Exchange Students and Acceptance Procedures

The students participating in the exchange program under the terms of this memorandum shall be selected initially by the home university, and the host university shall make final admission decisions in each case.

4. Study Program

The study program suitable for each student shall be determined by the host university with the students academic background and preferences taken into consideration.

5. Status of Exchange Students

Each university shall accept exchange students to the host university as a non-regular student who does not aim at obtaining a degree in the host university.

6. Academic Record and Accreditation

The host university shall evaluate the academic performance of each student pursuant to its rules and shall send to the home university the academic record or transcript of each exchange student. The home university may give credit to each student in accordance with its requirements.

7. Waiver of Tuition and Fees

Each host university shall provide waiver of examination fee, admission fee, and tuition for the exchange students.


8. Financial Responsibility

Exchange students shall take out comprehensive health insurance which is valid in the host university and shall be responsible for such expenses as travel, accommodation, and health care.

9. Accommodation

The host university shall do its possible to secure an appropriate accommodation for the exchange students.

10. This memorandum shall not ensure the availability of scholarships for the exchange students, but each university shall endeavor to provide useful information on scholarship programs that will financially assist the students.
11. This memorandum is subject to revision or annulment by mutual agreement, although such action shall only be taken after mutual consultation in order to avoid any possible inconvenience to the other party.
12. This memorandum shall become effective when the representatives of both universities have affixed their signatures thereto and shall be effective for five years. In the absence of six months' written notice of the annulment to the other party, the current memorandum shall be renewed automatically for the same duration.
13. This memorandum is to be executed in English.

BASIC AGREEMENT ON INTERNATIONAL EXCHANGE
BETWEEN
CHIANG MAI UNIVERSITY
AND
UNIVERSITY OF THE RYUKYUS

The President of Chiang Mai University and the President of the University of the Ryukyus, for the purpose of furthering cooperation in both education and academic research, hereby affirm their intent to promote such academic exchange as will be of mutual benefit for their respective universities. Academic exchange is considered here to include but not be limited to :

- (1) exchange of scholars, researchers, and administrative and technical staff ;*
- (2) exchange of students ;*
- (3) coordination of such activities as joint research and symposia ;*
- (4) exchange of data, documents, and research materials in fields of mutual interest.*

Details of the implementation of any particular exchange resulting from the agreement shall be negotiated between the two universities as each specific case may arise.

This agreement to promote academic exchange is subject to revision, renewal, or cancellation by mutual consent and becomes effective upon completion of the signatures.
